Amateur Athletic Waiver and Release of Liability Form

In consideration of being allowed to participate in any way in the Greater Kansas City Home School Association athletic/sports program, and related events and activities, the undersigned provides permission or provides consent individually for

Further, I authorize the Greater Kansas City Home School Association to authorize emergency treatment of an injury to or illness of my child if qualified medical personnel consider treatment necessary and perform treatment. This authorization is granted only if I cannot be reached and a reasonable effort has been made to do so. My child and I are aware that participating in certain sports is a potentially hazardous activity. I assume all risks associated with participation in the sport(s), including but not limited to falls, contact with other participants, and the effects of weather, traffic and other reasonable risk conditions associated with the sport(s). All such risks to my child are known and understood by me. I understand the Consent Form and agree to its condition in behalf of my child or for myself as an individual. In addition, you agree to the following:

1. Agree that the parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating he or she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition(s) and refuse to participate.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death and severe social and economic losses which might result not only from their actions, inactions, or negligence, but the action, inaction, and negligence of others, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent total disability or death.
4. Release, indemnify, waiver, discharge and covenant not to sue the Greater Kansas City Home School Association, it's affiliated clubs, their respective administrators, directors, agents, and other employees of the organization, other members/participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors or premises used to conduct the event, all of which are hereinafter referred to as "releases" from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses

or damages on account of injury, including death and damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.

I have read the above waiver and release, understand that I have given up substantial rights by signing it and sign it voluntarily.
